Lee moved, seconded by Beveridge to approve the educational pamphlets relating to the policy and procedure of the Nebraska Thoroughbred Breeders Association- NSRC Rule 24.101. Voting aye: Lee, Beveridge and Bakenhus. Nay: Galyen. Motion carried. Galyen moved, seconded by Beveridge to approve forms 100, 115, 125, 130, 135, 200, 250, 275, 300, 325 and 400. These forms will be used by the Nebraska Thoroughbred Breeders Association - NSRC Rule 24.001.02. Voting aye: Lee, Beveridge, Galyen and Bakenhus. Motion carried.
