By order of Nebraska Racing Commission Chairman Dennis P. Lee, the current agenda for the Racing Commission meeting scheduled for November 24, 2020 will be modified. Chairman Lee is concerned with the rise in Covid-19 cases and hospitalizations in Nebraska. He is concerned that if we keep our current agenda that we will have too many individuals at the meeting. This will violate the Governor's current DHM and create an unsafe meeting in the current environment.
