

Owner/Trainer Jim Cranwell accepts the lab results, foregoes any further defense of the alleged rule violations (including without limitation, waiver of a hearing) and accepts the penalty for violation of Nebraska State Racing Commission Rule 18.011 (Trainer is absolute insure of condition of horses trained by him and entered in a race and is responsible for the presence of any drug or medication in such horses). Truesdail Laboratories reported that the blood sample #77140 taken on May 25, 2020 from the horse "Five Roses Luna" who finished first in Race #3 contained the drug 7-Nor-7-Carboxycannabidiol. Trainer Jim Cranwell is hereby fined the sum of Five Hundred Dollar (\$500) and the horse "Five Roses Luna" is disqualified from 1st and placed last. The new order of finish is as follows; 1st Lucydoesthehula; 2nd Jakealina; 3rd Bella's Bluff; 4th Awesome Way; 5th Laine Peach; 6th Holiday Chimes; 7th Woke up Lady; 8th Five Roses Luna. Fine to be paid to the Nebraska Racing Commission within 72 hours.




